The Ministry of Blue Economy, Marine Resources, Fisheries and Shipping hereby inform the public that the Mauritius Maritime Training Academy (MMTA) in collaboration with Ecole Hôtelière Sir Gaëtan Duval (EHS GD) is launching the following course:

- **Ship's Cook Training Course**

2. The Ship's Cook Training Course is in line with the Maritime Labour Convention 2006, Regulation 3.2, Standard A3.2.
3. The course duration is 24 hours and course fee is Rs 5,200/- per participant payable to EHS GD.
4. Candidates should possess the minimum entry requirements mentioned hereunder:
  - (i) Be at least 18 years of age;
  - (ii) To be able to read, understand and write in English Language;
  - (iii) To be a holder of NC3 Certificate in food production from a recognised training institution; and
  - (iv) To be medically fit.
5. The course will be run by EHS GD from **8.30hrs to 15.00hrs for four (4) consecutive days.**
