

## **POLICE NOTICE**

### **YAMSEE FESTIVAL 2023**

In virtue of authority conferred upon me by Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made in connection with the Yamsee Festival 2023 styled "**LEVER DU GHOON**" "**CASSEE DU GHOON**" in Plaine Verte and Abercombie Division on Friday 28.07.2023 & Saturday 29.07.2023.

#### **2. CLOSURE OF ROAD (LEVER DU GHOON)**

**On Friday 28.07.2023 as from 20 00 hrs**

- (i) Pamplemouses Road from corner Dr Hassen Sakir Street up to Khadafi Square;
- (ii) Dr Hassen Sakir Street from corner and Ramsamy Canabady Street up to Pamplemouses Road;
- (iii) Magon Street from Khadafi Square up to Corner Ail Dore Street; and
- (iv) Sir Edgard Laurent Street from corner Nyon Street up to Khadafi Square.

#### **3. DIVERSION OF TRAFFIC**

- (i) Vehicles coming along Pamplemouses Road from the direction of Cite Laval Street and proceeding to Khadafi Square will be diverted onto Hyderabad Street;
- (ii) Vehicle coming along Dr Hassen Sakir Street will be diverted onto Paul et Virginie Street;
- (iii) Vehicle coming along Magon Street from the direction of Nicolay will be diverted on Khadafi Square towards Dr Joomye Street; and
- (iv) Vehicle coming along Sir Edgard Laurent from the direction of Vallee Pitot will be diverted onto corner Nyon Street and Ail Dore.

#### **4. NO PARKING & ZONE as from 14 00 hrs**

- (i) Dr Hassen Sakir Street (Ex Pagoda) from its junction with Pamplemoues Road up to Paul and Virginie Street; and
- (ii) Pamplemouses Road from Corner Dr Hassen Sakir Street up to Magon Street at Kadafi square.

## **5. CLOSURE OF ROAD (CASSER DU GHOON)**

**On Saturday 29.07.2023 as from 15.00 hours until all the Procession is over.**

- (i) Abercrombie Round About up to La Croisee Vallee des Pretres;
- (ii) Sophia Lane with its junction with Bernardin des St Pierre to La Croisee Vallee des Pretres;
- (iii) Military Road from its junction with St Francois Xavier Street up to Pamplémousses Road;
- (iv) Pamplémousses Road from La Croisee Vallee des Pretres up to Magon Street and all laterals Streets;
- (v) Dr Hassen Sakir Street (Ex Pagoda Street) from its junction with Pamplémousses Street to Paul et Virginie street, Plaine Verte;
- (vi) Cite Laval Street from its junction with St Francois Xavier Street up to Pamplémousses Road;
- (vii) Ambrosine Street from its junction with St Francois Xavier Street up to Pamplémousses; and
- (viii) Madras street from its junction with Pamplémousses up to St Francois Xavier Streets.

## **6. DIVERSION OF TRAFFIC on 29.07.2023**

(i) Buses and Vehicular traffic coming from the North along Pamplémousses Road proceeding towards the South and Immigration Bus Stand will be diverted at Abercrombie Round About into Nicolay Road via Noor E Islam Street onto Mariammen Temple Street to Immigration Bus Stand.

(ii) Buses and Vehicular traffic coming from Vallee des Pretres along Bernardin de St Pierre Street proceeding towards the South and Immigration Bus Stand will be diverted at Sophia Lane Le Cornu -Canal Bathust Street- Allee Pere Laval- Abercrombie Round About - Nicolay Road – Noor E Islam Street onto Mariammen Temple Street to Immigration Bus Stand.

## **7. BUS STOPS**

All Bus Stops along Pamplémousses street, Plaine Verte will *not be operational* for the embarkation and disembarkation of passengers on that day as from 15.00 hours.

## **8. MUSIC**

The processions will be accompanied by music style “CASSEE DU GHOON” which will be allowed only to those forming part of the “Ghoons”. Music will cease and silence observed whenever any of these processions come across any place of Worship or as so ordered by Police

## **9. NO PARKING ZONE as From 12.00 Hours**

(i) Dr Hassen Sakir Street (Ex Pagoda) from its junction with Pamplermouses Road up to Paul and Virginie Street will be a no parking zone as from 12.00 hours.

(ii) Pamplermouses Road from La Croisee Vallee Des Pretres up to Magon Street at Khadafi Square.

## **10. INTERFERENCE WITH PROCESSIONISTS**

No person shall unnecessarily interfere with or cause any annoyance to any person participating in the processions.

## **11. JUDICIAL PROCEEDINGS**

Non compliance with these traffic arrangements will entail judicial proceedings.
