#### VACANCY FOR THE POST OF INTERNAL AUDITOR/SENIOR INTERNAL AUDITOR

The Early Childhood Care and Education Authority (ECCEA), a parastatal body operating under the aegis of the Ministry of Education, Tertiary Education, Science and Technology is inviting applications from suitably qualified candidates who wish to be considered for appointment as **Internal Auditor/Senior Internal Auditor.** 

## **Age Limit:**

Candidates, unless already in the <u>Public Sector</u> (including parastatal bodies and Local Authorities), should not have reached their <u>45</u><sup>th</sup> birthday by the closing date for the submission of applications.

#### **Qualifications:**

- A. A pass at the final examinations required for admission to membership of one of the following bodies: -
  - (a) The Association of Chartered Certified Accountants;
  - (b) The Institute of Chartered Accountants of England and Wales;
  - (c) The Institute of Chartered Accountants of Scotland;
  - (d) The Institute of Chartered Accountants of Ireland;
  - (e) The Chartered the Institute of Management Accountants;
  - (f) The Chartered the Institute of Public Finance and Accounting.

An equivalent qualification acceptable to the Board.

B. At least three years' experience in auditing and/or accounting duties.

Candidates should produce written evidence of experience claimed.

### 3. Duties and Salary

- 1. To recommend improvements to records and achieve more accurate and useful data and eliminate errors, defalcation, waste and fraud.
- 2. To report on deficiencies found and propose improvement to the system.
- 3. To train subordinate staff.
- 4. To ascertain that statutory provisions and internal regulations are being complied with.
- 5. To verify all accounting statements produced for statutory purpose or for management.
- 6. To maintain close liaison with the Organisation's external auditors to ensure that audit programmes are well coordinated.
- 7. To carry out value for money audit and any special investigation as may be assigned by the Director.
- 8.To prepare audit guides and instructions.
- 9. To perform such cognate duties as may be assigned.

The permanent and pensionable post carries salary in the scale Rs  $30700 \times 825 - 35650 \times 900 - 37450 \times 950 - 42200 \times 1300 - 46100 \times 1575 - 49250 \times 1650 - 54200 \times 1700 - 64400 \times 1800 - 69800$  a month.

#### **MODE OF APPLICATION:**

1. Qualified candidates should submit their applications on the <u>prescribed form</u> that can be obtained at the reception desk of the Early Childhood Care and Education Authority or downloaded from the website on <u>www.eccea.mu</u> together with photocopies of their academic qualifications.

The post of 'Internal Auditor' Senior Internal Auditor' should be clearly marked on the top-left hand corner of the envelope.
