

## POLICE COMMUNIQUE

### **Localised Temporary Restrictions of Movement Order made by the Prime Minister under section 3 of the Quarantine Act 2020**

Pursuant to General Notice No 993 of 2021, members of the Public are hereby being informed that for the purpose of preventing the spread of Covid-19 in Mauritius, all persons resident in: Cité Martial/Plaine Verte – Morcellement Goolamally, Le Hochet, Terre Rouge – Riche Terre, as described herein after, shall remain indoor until 26 July 2021 at 8 p.m.

2. Moreover, persons resident in an area specified above shall, at no time, leave that area, and persons not resident in an area specified above shall, at no time enter that area.

3. However, paragraph 2 shall not apply to the following persons or class of persons who have to leave, or enter, the area specified above

- (a) a person who has to avail himself, or to any other member of his family, of medical treatment, or to procure medicine, or any other item essential for his or his family's subsistence or livelihood;
- (b) a person who is authorised to be outdoor strictly on allocated days or authorised to carry out specific activities;
- (c) employees of the Disciplined Force while on official duty;
- (d) a Judge or Magistrate, or an officer of the Judiciary, designated by the Chief Justice;
- (e) a medical practitioner for the purpose of attending a hospital or private health institution, or for the purpose of domiciliary visits;
- (f) a pharmacist for the purpose of attending his pharmacy;
- (g) a person who has to avail his pet of veterinary treatment;
- (h) a person required to attend a Court by virtue of a summons issued by the Court;
- (i) a person who is issued with a permit by the Commissioner of Police under section 3(2) of the Quarantine Act 2020.

## DESCRIPTION OF RED ZONE AREAS

### CITE MARTIAL/PLAINE VERTE

Bounded by –

- a) **Northern Side** - Abdool Razack Mohamed Street from its junction with “Canal Anglais” up to its junction with Magon Street
- b) **Western Side** - Magon Street from its junction with Abdool Razack Mohamed Street up to its junction with Diego Garcia Street
- c) **Southern Side** - Diego Garcia Street from its junction with Magon Street up to “Canal Anglais”
- d) **Eastern Side** - “Canal Anglais” from Diego Garcia Street up to Abdool Razack Mohamed Street

## **MORCELLEMENT GOOLAMALLY, LE HOCHET, TERRE ROUGE**

Bounded by –

- a) **Northern Side** - Junction MHC and Reservoir Road along Reservoir Road until junction Mosque Road
- b) **Eastern Side** - Junction Veerasami Iyer and MHC Lane along MHC Lane until junction Alamandas Lane
- c) **Western Side** - Junction Veerasami Iyer and Mosque Road along Mosque Road until junction of Northern Boundary
- d) **Southern Side** - Veerasami Iyer Road from its junction to Mosque up to MHC Lane

## **RICHE TERRE**

Bounded by –

- a) **Northern Side** - Junction Bissoonath Road and motorway along motorway up to junction motorway and bridge and Royal Road Terre Rouge (Quincaillerie INGCO)
- b) **Eastern Side** - Junction bridge and Royal Road Terre Rouge along Royal Road Terre Rouge up to Dr Manilall Road
- c) **Western Side** - Junction Dr Manilall Road and Bissoonath Road along Bissoonath Road until junction of motorway
- d) **Southern Side** - Junction Royal Road Terre Rouge along Dr Manilall Road and Bissoonath Road until junction of Bissoonath Road

Members of the Public are hereby informed that the Police will exercise strict control with regards to persons entering and exiting the re-defined Red Zones. Residents of the above mentioned areas shall at no time travel outside those areas and non-residents shall at no time enter those areas except frontliners of the essential services.

### **Penalty**

Unauthorised persons found outdoor shall commit an offence under the Quarantine Act 2020 and shall, on conviction be liable to a fine not exceeding 500, 000 rupees and to imprisonment for a term not exceeding 5 years.
