

POLICE NOTICE

HORSE RACE MEETING IN CAMERA AT THE CHAMP DE MARS

By virtue of authority conferred upon me by Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made in Port Louis, on all days when Horse Race Meetings will be held in camera at the Champ de Mars. The public shall strictly comply with these arrangements unless otherwise directed by Police.

2. CLOSED STREETS FOR VEHICULAR TRAFFIC (EXCEPT FOR RESIDENTS FROM 1030 HRS TO 1730 HRS)

- a) Frere Felix de Valois Street as from its junction with Labourdonnais Street up to Boulevard Victoria (Ex Military Road);
- b) Eugene Laurent Street as from its junction with Boulevard Victoria to that with D'Estaing Street;
- c) D'Estaing Street as from its junction with Eugene Laurent Street to that with Frere Felix e Valois Street;
- d) Mgr Gonin Street a from its junction with GMD Atchia Street to that with D'Estaing Street;
- e) Pope Hennessy Street as from its junction with Labourdonnais Street to that with D'Estaing Street;
- f) Church Street as from its junction with GM Atchia Street to that with D'Estaing Street;
- g) Corneille Street as from its junction with Sebastopol Street to that with Eugene Laurent Street; and
- h) Shakespeare Street as from its junction with Boulevard Victoria to that with Herschel Street.

3. NO PARKING ZONE FROM 0600 HRS TO 1730 HRS

All the stretches of close streets mentioned in paragraph 2 above as well as Boulevard Victoria(Ex-Military Road)will be a NO Parking Zone on both sides. Only authorized persons will be allowed to park their vehicles in Champ de Mars.

4. TWO-WAY TRAFFIC

Mahatma Gandhi Street as from its junction with Langlois Street to that with St Denis Street will be converted into a two-way street.

5. ACCESS TO CHAMP DE MARS AND SHAKESPEARE STREET

All holders of Access Permits will enter Le Champ de Mars through Pope Hennessy Street where there will be a Police Control Point. No other persons whether on foot or on board of vehicles will be allowed access thereat.

6. RESTRICTIONS FOR PEDESTRIANS

No person, other than holders of Access Permits and residents, shall be allowed access on both sides of and on the under mentioned streets:

- a) Boulevard Victoria (ex Military Road) as from its junction with Frere Felix de Valois Street to that with Inkerman Street;
- b) Eugene Laurent Street as from its junction with Boulevard Victoria to that with D'Estaing Street;
- c) D'Estaing Street as from its junction with Eugene Laurent Street to that with Frere Felix e Valois Street;
- d) Frere Felix de Valois Street as from its junction with Labourdonnais Street to that with Boulevard Victoria; and
- e) Corneille Street as from its junction with Sebastopol Street to that with Eugene Laurent Street.

7. JUDICIAL PROCEEDINGS

Non compliance with these traffic arrangements will entail judicial proceedings.

The cooperation and understanding of the public would be much appreciated.
