**Vacancy for Post of Assistant Inspector of Works  
Ministry of National Infrastructure and Community Development  
(National Infrastructure Division)**

The Public Service Commission invites applications from suitably qualified candidates who wish to be considered for appointment as Assistant Inspector of Works in the Ministry of National Infrastructure and Community Development (National Infrastructure Division).

**Salary:** Rs 17,305 a month in a scale from Rs 17,305 to Rs 36,550 (26 032 069)

**Core Qualifications:**

Candidates should possess -

- A.** a Cambridge School Certificate with credit in at least five subjects including English Language, French and Mathematics or Principles of Accounts obtained on one certificate or Passes not below Grade C in at least five subjects including English Language, French and Mathematics or Principles of Accounts obtained on one certificate at the General Certificate of Education “Ordinary Level” or an equivalent qualification acceptable to the Public Service Commission.

**Note**

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at “Principal Level” and one subject at “Subsidiary Level” as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.

- B.** (i) the Ordinary Technician Diploma in Building and Civil Engineering awarded by the City and Guilds of London Institute or
- (ii) the Technician Diploma in Construction or in Construction Industry awarded by the City and Guilds of London Institute or
- (iii) the “Brevet de Technicien” in Building Construction (Bâtiment) awarded jointly by the Mauritius Examinations Syndicate and the Lycée Polytechnique Sir Guy Forget.
