A. (I) QUALIFICATIONS	(i) A Cambridge Higher School Certificate or passes in at least two subjects obtained on one certificate at the General Certificate of Education 'Advanced Level' (ii) Diploma in Management or Business Management or Logistics & Transport or Port Management & Shipping Administration or equivalent
(II) EXPERIENCE	At least 5 years' post qualification experience in administrative field, out of which 3 years should be at a senior position
OR	
B. (I) QUALIFICATIONS	Certificate of Competency (CoC3) Deck Officer or Certificate of Competency as Skipper of fishing vessel of not less than 24m issued by Directorate of Shipping
(II) EXPERIENCE	At least 10 years' sea-going experience, out of which 3 years should be as Senior officer
AGE LIMIT FOR ENTRY	Candidates should be 40 years of age or below by the closing date of submission of applications

Note: Candidate holding the qualifications at (A) but not possessing required experience at (A) may also be considered for employment on a contract basis provided the applicant reckons at least 2 years' experience in administrative field at middle management level.
