The Disciplined Forces Service Commission invites applications from suitably qualified candidates who wish to be considered for appointment as Woman Prisons Officer/ Senior Woman Prisons Officer in the Mauritius Prison Service.

**Age Limit:** Between **18** and **30** years

**Salary:** Rs 18,650 a month in a scale from Rs 18,650 to Rs 39,350

**Core qualifications:**

Candidates should -

- A. possess a Cambridge School Certificate with at least a pass in English Language, French Language and Mathematics or Principles of Accounts or Passes obtained on one certificate at the General Certificate of Education "Ordinary Level" either (i) in five subjects including English Language, French Language and Mathematics or Principles of Accounts with at least Grade C in any two subjects or (ii) in six subjects including English Language, French Language and Mathematics or Principles of Accounts with at least Grade C in any one subject or an equivalent qualification acceptable to the Disciplined Forces Service Commission;
- B. have a good physique with their **Body Mass Index (BMI)** values ranging between **18.50** and **27.50** and they should be able to undergo strenuous physical exercise;
- C. have a normal eyesight (without glasses or contact lenses);
- D. satisfy the minimum physical requirement of **1 m 63**; and
- E. be computer literate.
