**THE QUARANTINE ACT 2020**

**Order made by the Prime Minister under section 3 of the Quarantine Act 2020**

1. WHEREAS by virtue of General Notice No. 512 of 2021, I ordered, pursuant to paragraph 4(2) of the said Order, that persons resident in an area listed in the Appendix to the said Order shall, at no time, travel outside that area and, persons not resident in an area listed in the Appendix to the said Order shall, at no time, enter that area.
2. NOW, I designate that the areas specified in Appendix I to this Order shall not apply to the towns and villages situated within the constituencies of La Caverne and Phoenix (No. 15), Vacoas and Floreal (No. 16) and Curepipe and Midlands (No. 17).
3. I further designate, in addition to the areas specified in the Appendix to the Order made by virtue of General Notice No. 512 of 2021, that persons resident in an area listed in Appendix II to this Order shall, at no time, travel outside that area and, persons not resident in an area listed in Appendix II to this Order shall, at no time, enter that area.
4. This Order shall be in addition to, and not in derogation from, the Order made by virtue of General Notice No. 512 of 2021.
