THE QUARANTINE ACT 2020

Localised Temporary Restrictions of Movement Order made by the Prime Minister under section 3 of the Quarantine Act 2020

- **1.** WHEREAS by virtue of General Notice No. 611 of 2021, it was ordered, in view of the fact that there was still an epidemic of COVID-19 in Mauritius, that the *quarantine period* in Mauritius be extended until 31 July 2021.
- **2.** WHEREAS section 3(1)(b) of the Quarantine Act 2020 provides that, during a *quarantine period*, the Prime Minister may, by Order, order that all persons shall remain indoor within such area and during such period, and under such terms and conditions, as he may specify.
- **3**. (1) NOW, in view of the fact that I am satisfied that it is necessary and expedient for the purpose of preventing the spread of COVID-19 in Mauritius, I order that all persons resident in an area listed
 - (a) in Part A to the Appendix shall remain indoor until 21 May 2021 at 8 p.m.;
 - (b) in Part B to the Appendix shall remain indoor until 27 May 2021 at 8 p.m.; and
 - (c) in Part C to the Appendix shall remain indoor until 29 May 2021 at 8 p.m.
- (2) MOREOVER, persons resident in an area listed in Part A, B or C to the Appendix shall, at no time, travel outside that area, and persons not resident in an area listed in Part A, B or C to the Appendix shall, at no time, enter that area.
- **4.** However, paragraph 3 shall not apply to the following persons or class of persons who have to travel outside, or enter, an area listed in Part A, B or C to the Appendix
 - (a) a person who has to avail himself, or to any other member of his family, of medical treatment, or to procure medicine, or any other item essential for his or his family's subsistence or livelihood;
 - (b) a person who is, pursuant to the COVID-19 (Closing Down of Premises and Restriction of Activities) (No. 2) Regulations 2021, authorised to be outdoor strictly on allocated days or authorised to carry out specific activities;
 - (c) employees of the Disciplined Force while on official duty;
 - (d) a Judge or Magistrate, or an officer of the Judiciary, designated by the Chief Justice;

- (e) a medical practitioner for the purpose of attending a hospital or private health institution, or for the purpose of domiciliary visits;
- (f) a pharmacist for the purpose of attending his pharmacy;
- (g) a person who has to avail his pet of veterinary treatment;
- (h) a person required to attend a Court by virtue of a summons issued by the Court;
- (i) a person who is issued with a permit by the Commissioner of Police under section 3(2) of the Quarantine Act 2020.
- **5.** Nothing shall exempt any employer from his statutory obligations pertaining to the safety and health of his employees under any enactment which may be applicable.
- **6.** This Order is being issued in the interest of public health and to protect the population. Members of the public are urged to be self-disciplined and, whilst being outdoor as authorised, to strictly abide to the COVID-19 (Closing Down of Premises and Restriction of Activities) (No. 2) Regulations 2021 and to the Preventive and Sanitary Measures (COVID-19) Regulations 2021.
- 7. Any person who is found outdoor in breach of this Order shall commit an offence and shall, on conviction, be liable to a fine not exceeding 500,000 rupees and to imprisonment for a term not exceeding 5 years.
- **8.** General Notice No. 614 of 2021 is being revoked.
- **9.** This Order shall take effect on 8 May 2021 at 6 a.m.

- Solferino No. 3 Avenue from it junction with Candos-Vacoas Road (B3) up to its junction with Impasse Mangoo
- (b) Western Side: Impasse Mangoo from its junction with Solferino No. 3 Avenue up to its junction with Solferino No. 2 Avenue
 - Solferino No. 2 Avenue from its junction with Impasse Mangoo up to its junction with Manilall Doctor Avenue
 - Manilall Doctor Avenue from its junction with Solferino No. 2 Avenue up to its junction with Candos - Vacoas Road (B3)
- (c) Southern Side: Candos Vacoas Road (B3) from its junction with Manilall Doctor Avenue up to its junction with Mahant Kabir Temple Road
 - Mahant Kabir Temple Road from its junction with Candos-Vacoas Road (B3) up to its junction with Convent Lane
- (d) Eastern Side:
- Convent Lane from its junction with Mahant Kabir Temple Road up to its junction with Phoenix Cemetery Road
- Phoenix Cemetery Road from its junction with Convent Lane up to Remy Ollier Avenue
- Remy Ollier Avenue from its junction with Phoenix Cemetery Road up to its junction with Droopnath Ramphul Avenue
- Remy Ollier Avenue from its junction with Droopnath Ramphul Avenue up to its junction with Carreau Lalianne Branch Road
