Requirements:

- (iii) To carry out visits to places of detention, as and when necessary for investigation;
- (iv) To attend hearings of the Human Rights Division and of the National Preventive Mechanism Division:
- (v) To prepare notes of evidence in connection with cases under investigation;
- (vi) To counsel and provide authorised information to complainants regarding their grievances and answer queries from members of the public;
- (vii) To organise and participate in promotion and awareness campaigns on Human Rights Issues;
