- 1. The Ministry of Housing and Land Use Planning invites sealed bids from eligible bidders for 3 vehicles on an "as is where is" basis. Bidders may submit bids for all the 3 vehicles or for any of the vehicles.
- 2. Prospective bidders may view the vehicles prior to bidding on **Thursday 16 January 2020** as from 10 00hrs to 15 00hrs in the parking space of the Ministry of Housing and Land Use Planning, Ebene Tower, Plot 52, Ebene. - **3.** Interested bidders are invited to submit their bids on the prescribed form which is available at the Reception Counter, Level 2, Ministry of Housing and Land Use Planning, Ebene Tower, Plot 52, Ebene as from 09 00hrs to 15 45hrs.
- **4.** Bids in sealed envelope duly filled, signed and clearly marked "Sale of Unserviceable Vehicles" should be deposited in the Tender Box located at Level 2, Ministry of Housing and Land Use Planning, Ebene Tower, Plot 52, Ebene not later than **13 00hrs on Tuesday 21 January 2020**. Any offers received after the expiry date and time will not be considered.
- 5. Bidders must consider the vehicles sold on an "as is where is "basis and the successful bidder/s will be responsible for all costs including the removal and transportation of the vehicles in accordance with the laws and regulations.
- **6.** There will be a minimum reserve price for each vehicle and, therefore, the offer will be awarded on the highest bid received without restriction.
- 7. Bidders should submit together with their bid/s, an office cheque drawn by a local bank in favour of the Government of Mauritius for the sum representing 5% of their offer.
- **8.** Bids shall remain valid for 30 days beyond the deadline for submission of bid.
- **9.** Bids will be opened in the Conference Room, Level 7, of the Ministry on the same day at 13 15hrs in the presence of bidders/bidders' representatives who may choose to attend.
- 10. The successful bidder/s shall effect payment of the remaining balance and take delivery of the vehicles within 7 days as from the date of the Letter of Award, failing which the offer will lapse and the amount on the office cheque submitted shall be forfeited. Payment will be accepted only by cash or office cheque in favour of Government of Mauritius.
- **11.** Unsuccessful bidders will be refunded the amount deposited within 2 weeks as from date of award of bid/s.
